- 5. That my client has raised an invoice on time on 13-2-2023 for an amount of Rs. 1666/- which was the salary earned by the worker for 7 working number of days in the month of February in the year 2023. The said invoice has been sent to you over email ID: Kunaldev1981@gmail.com

That inspite of acknowledging the liability of payment of principal balance of Rs.1666/- you have failed to make payment of the said amount due to my client from you deliberately with malafide intent, hence you are liable to pay the said principal balance amount of Rs.1666/- along with interest @ 24% p.a.
